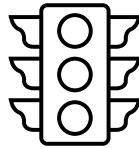

Subject: UPDATE REGARDING THE ROSSMOOR COMMUNITY SERVICES DISTRICT REQUEST TO ORANGE COUNTY PUBLIC WORKS FOR TRAFFIC SAFETY UPGRADES THROUGHOUT THE COMMUNITY

RECOMMENDATION

Review and discuss information provided.

INFORMATION

The General Manager presented a report at the May 11, 2021 Rossmoor Community Services District (RCSD) Board meeting outlining that Orange County Public Works (OCPW) confirmed the placement of two permanent Radar Speed Feedback Signs (RSFS) would be purchased and installed within Rossmoor. The exact locations are under study. One location will be along St. Cloud Drive before the curve at the Library, and a second will be on Montecito Road near the Montecito Center. The addition of more permanent RSFS along Foster Road and Martha Ann Drive at the flood control channels has been requested by the General Manager on behalf of the Community Traffic/Safety Advisory Ad Hoc Committee and is under consideration by OCPW.

The following items (in coordination with OCPW) have been discussed previously, but are included for historical purposes:

1. Replace current 30-inch stop signs at Bradbury Road, Copa De Oro Drive, and Mainway Drive on both sides of Montecito Road, with 36-inch stop signs for better visibility. *Work order was completed on 2/17/21.*
2. Provide a strip of retroreflective material on the supports of the stop signs identified above; material to be at least 2-inches in width, placed for the full length of the support from the sign to within 2-feet above the edge of the roadway, and its color shall match the background color of the sign, to further enhance visibility. *Work order was completed on 2/17/21.*
3. Work with the California Highway Patrol (CHP) and OCPW to schedule their respective portable Radar Speed Feedback Sign (RSFS) trailers throughout the community during 2021. *Deployment was postponed a week due to the weather; will begin deployment on*

Monday, 3/29/21 on Tigertail. Update: the portable RSFS are being placed and we are receiving positive feedback from residents.

4. Staff is working with OCPW to review a Geographic Information System (GIS) map that will show locations of existing street signs, street markings and bike routes within Rossmoor. Following review, this information will be presented at a future Traffic Safety Advisory Ad Hoc Committee.

5. At their February 9, 2021 RCSD Board meeting, the Board of Directors moved to approve the addition of parking lanes from St. Cloud Drive to Montecito Road, through Orangewood Avenue. Orange County Public Works (OCPW) has confirmed that work will begin in July 2021 to stripe the parking lane lines as requested by the RCSD Board. This measure will change the width of driving lanes in order to slow down traffic.

Subject: GENERAL MANAGER UPDATES REGARDING TRAFFIC/SAFETY ITEMS IN THE ROSSMOOR COMMUNITY SERVICES DISTRICT

RECOMMENDATION

Review and discuss information provided.

BACKGROUND

An overview of traffic-safety-related items will be provided by the General Manager. This may also include an update on items previously discussed by the Community Traffic Safety/Advisory Ad Hoc Committee.

INFORMATION

The following information is provided.

1. Street Sweeping: The proposed street sweeping schedule change is under study. There are a number of variables that need to be addressed prior to requesting Supervisor Katrina Foley's assistance in passing a new street sweeping ordinance. Although we have been working on changing the street sweeping schedule for nearly two years, the challenge now is that the County is changing Rossmoor's trash collection program to include a new three-barrel system that is anticipated to begin in the next few months. Therefore, our efforts with regard to the street sweeping schedule, will now have to accommodate the trash collection changes. At this point, the first step is to coordinate with the Orange County Waste and Recycling Department regarding the new trash collection program that will be introduced in Rossmoor. This new program will include a three-barrel collection process to collect solid waste, recyclables, and green waste. The next step is to collaborate with both the trash hauler and street sweeping vendors to review the trash and street sweeping schedules to be sure both complement one another. Once this is accomplished, the District can move forward with negotiating the odd/even Monday street sweeping schedule, as well as addressing any signage that may need to be changed.

Representatives from Orange County Waste and Recycling and the trash hauler will be presenting an overview of the new three-barrel collection process and marketing plan at the June 9, 2021 and July 13, 2021 Rossmoor Community Services District (RCSD) Board meetings.

2. Roadway Resurfacing Project: The Orange County Public Works (OCPW) tentative FY 2021-22 Roadway Resurfacing project is scheduled to begin in July 2021. A map and schedule will be provided to the District in the near future. Once received, both OCPW and RCSD will be marketing the project timeline to the community. A new part of the project will be the resurfacing of the parking lot surrounding Rossmoor Park. It is anticipated this part of project will be mobilized mid-August 2021.

3. Trunk Project: Review of the trunk project along Los Alamitos Boulevard and Seal Beach Boulevard. The bid period for the project closed and the contract was submitted to the Board of Supervisors in May for award. Once the contract is approved, a schedule will be set and shared and marketing/outreach efforts will begin. The project is scheduled to begin summer 2021. Below is a description of the project:

As reported the Los Alamitos Trunk Sewer project will make improvements to two parallel sewer lines and associated manholes along a two-mile stretch of Seal Beach Boulevard/Los Alamitos Boulevard from just north of the I-405 freeway to Katella Avenue in the cities of Seal Beach and Los Alamitos. Also being repaired is the sewer on Katella Avenue from Oak Street to Lexington Drive. A map can be found on the Orange County Sanitation District website at www.ocsan.gov/losalamitos.

4. Traffic Safety Campaign – Yard Signs: As part of the traffic safety campaign, the RCSD has developed a traffic safety sign for distribution to residents. The yard signs promote reminders for vehicles to drive within the 25-mile-per-hour speed limit.



The free yard signs may be picked up at the RCSD office, 9 a.m. to 5 p.m., Monday – Friday.

5. County of Orange Active Transportation Plan Survey: The County of Orange sent out a 'Walk, Bike or Roll in Rossmoor' mailer to all residents, with a QR code link to the online survey. The survey is seeking opinions on improvements needed for pedestrians and bicyclists in Rossmoor. Here is the link to the survey in English: bit.ly/walkbikeocpw.
