The Tuesday, January 13, 2015 regular meeting of the Rossmoor Community Services District began with former President Michael Maynard’s 2014 State of the District Address.

“Calendar year 2014 proved to be another year of progress for our district.” He stated. Maynard continued by highlighting the district’s significant accomplishments which included activism on issues such as I-405 toll road opposition led by Director Casey and opposition of the installation of Southern California Edison smart meter data collection units in Rossmoor, led by former Director Coletta. In his speech Maynard also touched on the hiring of new General Manager James D. Ruth, the continued pursuit of latent powers, urban forest management, prudent financial administration and various capital improvements over the past year.
